Endnotes:

1. A Form 11-K annual report for a plan not subject to ERISA is due 90 days after the plan's fiscal year end. The deadline is 180 days after the plan's fiscal year end for plans subject to ERISA.

2. If the Form 10-K incorporates information from the proxy statement, the proxy statement must be filed no later than 120 days after the fiscal year end. If the proxy statement is not filed by that deadline, the Form 10-K must be amended to add the Part III information.

Weekends & Holidays: When a filing deadline falls on a weekend or holiday, it is automatically extended to the next business day under Exchange Act Rule 0-3. The filing dates in this calendar reflect automatic extensions under Rule 0-3.

EDGAR Hours: Filings may be submitted to EDGAR between 6:00 am and 10:00 pm Eastern Time on weekdays, excluding holidays. Filings submitted after 5:30 pm Eastern Time will receive the next day's filing date, except for Section 16 filings and filings under Securities Act Rule 462(b) (which receive the actual filing date).

Filing Extensions for Certain Forms: Filers may request an extension of the filing deadline for Form 10-K, Form 10-Q or Form 11-K by filing a Form 12b-25 no later than 5:30 pm Eastern Time on the business day after the original filing deadline. Filers may receive an additional five days to file Form 10-Q and an additional 15 days to file Form 10-K or Form 11-K.
